



Technical Services Bulletin OateySCS Products and "LEED" (1/2012)

This technical bulletin covers two topics.

- 1. LEED points available for OateySCS products.
- 2. Information on VOC value to use when filling out LEED paperwork.
- "LEED" stands for "Leadership in Energy and Environmental Design." It is comprised of a set of rating systems for different types of construction which have been developed by the U.S Green Building Council. The most familiar rating system is "LEED-NC" which covers new commercial and institutional buildings and major renovations; "LEED-Homes" is newer and covers residential construction. OateySCS products that qualify for LEED points are Plastic Pipe Solvent Cements, Primers, Cleaners, Acrylic and Silicone sealant.

For "LEED-NC" – 1 LEED point available when all adhesives and sealants used on the job comply with SCAQMD Rule 1168.

The applicable credit category is Indoor Environmental Quality (IEQ) Credit 4.1: Low-Emitting Materials – Sealants and Adhesives and the requirement is compliance to South Coast Air Quality Management District (SCAQMD) Rule 1168 for Volatile Organic Compound (VOC) limits as indicated in the table in Section 4.1. (Table 1 at the end of the bulletin is a recreation) **Note:** Compliance of **ALL** adhesives and sealants, used in a building, with Rule 1168 results in one point towards the point total for the building.

For "LEED-Homes" – 1/2 LEED point available for each product used that complies with SCAQMD Rule 1168, up to a maximum of 8 points.

The applicable credit category is Material and Resources (MR) 2.2 Environmentally Preferable Products section b and also requires compliance to SCAQMD Rule 1168 as indicated by Table 26. The difference between the "LEED-NC" and "LEED-Homes" systems are the points awarded. For "LEED-Homes" each component that meets the requirements of MR 2.2 earns 0.5 point up to a maximum of 8 points for the category. There is no stipulation that all adhesives and sealants must comply with rule 1168.

2. When filling out "LEED" paperwork use the following information. It is the responsibility of someone involved with the construction project to fill out the necessary paperwork.
